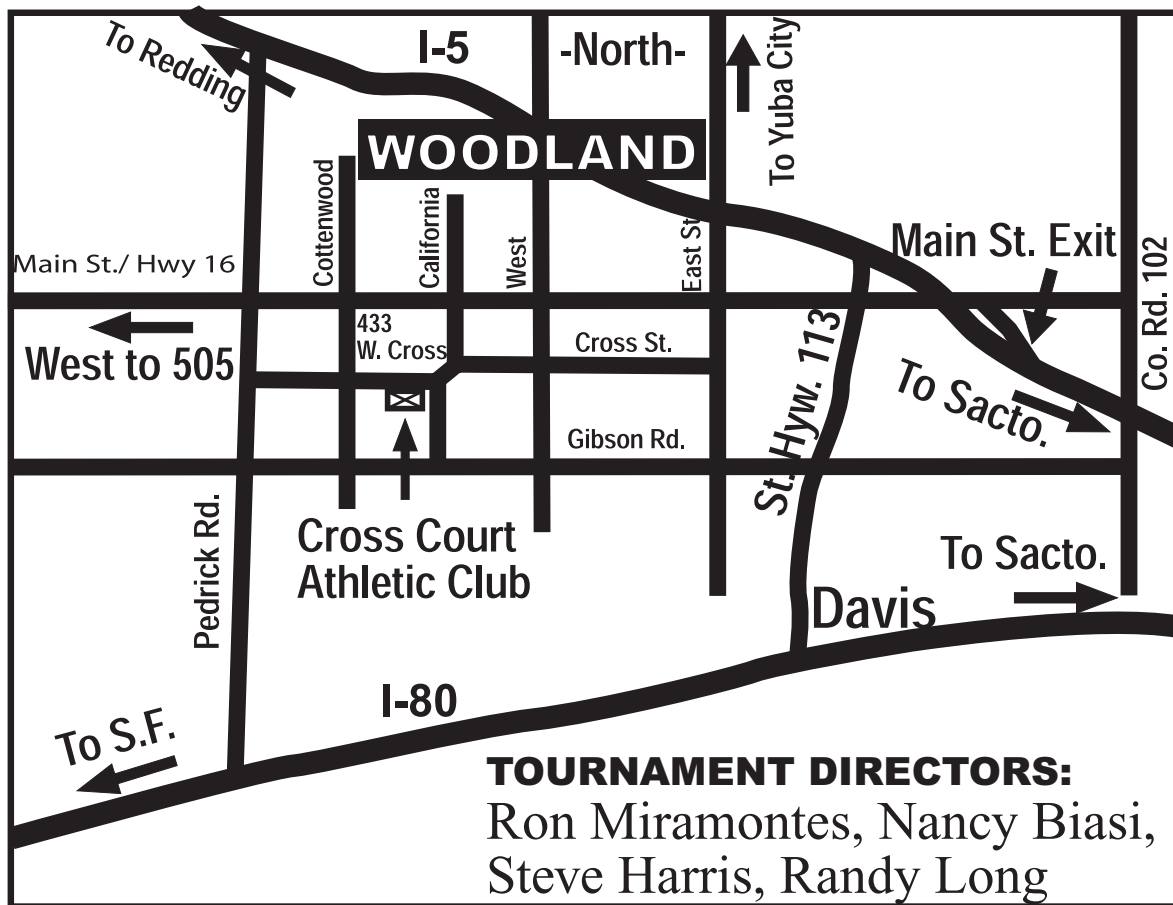
Referee Assignments LOSERS MUST REFEREE TO RECEIVE THEIR SOUVENIR
